### 2. Collecting personal data

NSD International B.V. will collect your personal data in case our services are used and/or because personal data is provided to us.

We collect the following data:

- Name and last name
- Gender
- Job title
- Organisation
- Address details
- Invoice and payment details
- E-mail address (also as opt-in for e-mails)
- IP address (in case you receive our e-mails we also register your interactions (open- and click-behaviour))
- Phone number

### 3. Collecting special and/or sensitive personal data

Our website and/or service does not intent to collect data from website visitors under the age of 16, unless they have got permission from a parent or guardian. Though we cannot verify if a visitor is above the age of 16. Therefor we advise parents, in order to prevent the collection of personal data from children without permission, to be involved in the online activities of their children. ### 4. The purpose and fundament on which we collect personal data

NSD International B.V. collects your personal data with the following purposes:

- To call or e-mail you in case it is necessary to provide our services and to adapt our services to your needs in a better way than we did before.

## 5. Automated decision-making

NSD International B.V. does not make decisions about matters that may have (significant) consequences for people based on automated processing. Automated processing means decisions made by computer programs or systems without involving a person (for example, a NSD International B.V. employee).

## 6. Duration of storing personal data

NSD International B.V. will not store your personal data any longer than strictly necessary to achieve the purpose on which we collect your data. For the following (categories of) personal data we use the following retentions:

- Name, last name, gender, address details: until the person unsubscribes from one of our newsletters or services.
- Invoice and payment details: seven years, like the fiscal retention requires.

## 7. Sharing personal data with third parties

NSD International B.V. exclusively and only shares personal data with third parties if necessary to fulfil our agreement or to comply with a legal obligation.

## 8. Cookies, or comparable techniques, we use

NSD International B.V. uses functional, analytic and tracking cookies. A cookie is a small text file which will be saved in the browser of your computer, tablet or smartphone when you are visiting our website for the first time. The cookies NSD International B.V. uses do have a purely technical functionality. These cookies ensure the website works properly and, for example, that your preferred settings are remembered. They are also used to optimize our website and to offer you personalized content and ads.

We have informed you about these cookies and asked your permission to use them when you visited our website for the first time.

You can stop cookies being installed on your browser by setting your cookie preferences before you start surfing.
